

Guidance Application Procedures For OkACTE New Professional Award *Process Sheet*

Purpose: To contribute to the professional development of members recognized as potential leaders of their division and the association. Six awards will be given by OkACTE to provide funding to attend the ACTE conference. Each recipient will also receive a complimentary registration to the OkACTE Legislative Seminar.

Eligibility: The award will be given to an individual who has been a primary member of the Guidance Division no less than two, but no more than five years. The nominee must not have previously attended an ACTE Convention. Since the purpose of the award is professional development, award recipients are required to attend the entire convention, beginning with the Opening General Session through the Closing General Session including the Delegate Assembly.

Guidance Deadlines: **Application Nomination Form and Additional Documentation to Awards Co-Chair by **February 15, 2011** or before.**
Interview March 9th, 2011, TBA

1. Submit a one page description of your current position and professional objectives. In addition, discuss your goals and vision for your professional development.
2. Submit a 1-2 page resume that will include:
 - a) Professional Memberships and Professional Association Activities (include dates of involvement)
 - b) Professional contributions, publications, presentations (include dates of these activities)
 - c) Educational and Work Experience
 - d) Civic and Community Involvement (include dates of involvement)
3. Submit the attached nomination form for this award.
